

AACUSS Award of Merit

Description:

Initiated in 1984, the Award of Merit is the highest honour the Association gives to one of its members and is presented at the annual Atlantic Association of College and University Student Services (AACUSS) Conference or AGM. The Award is based on merit and, therefore, may not be presented every year.

The Award of Merit is presented in recognition of the following:

- Significant achievement and distinguished contribution to the development and promotion of Student Services in the Atlantic Region and active participation in AACUSS
- Active participation could include involvement in committees, divisions, or the executive.
- Active participation includes long-standing involvement (10+ years) with the association through participation at annual AACUSS conferences, workshop facilitation, presentations, undertaking research, mentoring, leadership, or advocacy on regional issues.
- Award of Merit recipients are well-respected contributors to Student Services in Atlantic Canada and have made significant contributions to their campus communities.

Minimum Criteria Check

- Long-standing (10+) years of membership
- Involvement in AACUSS
- Nomination Letter, no more than 1000 words
- Support letter(s) (minimum 1, maximum 3, no more than 500 words each)
